IN ADDITION TO MEETING BASIC NEEDS OF SHELTER, FOOD AND CLOTHING, SAINT MARTHA'S OFFERS WEEKLY SUPPORT GROUPS, PARENTING SUPPORT, EXTENSIVE CHILDREN'S SUPPORT AND ACCESS TO INFORMATION AND REFERRALS. IN 2022, SAINT MARTHA'S OPENED A DROP IN CENTER TO PROVIDE HELP TO WOMEN IMPACTED BY DOMESTIC VIOLENCE WHO AREN'T SEEKING SHELTER, PLUS RESOURCES FOR THEIR FAMILIES AND FRIENDS.
